- If the vehicle you are using does not belong to you: a copy of your rental or lease contract made out in your name

The car park has a number plate recognition system at the entrance and exit and the registered number plate gives you access to the car park.

****Only 50 P+R spaces are available. If the car park is full, your application will be placed on a waiting list and you will be notified. When a space becomes available, we will email you to inform you about the activation of your subscription.**

General Terms and Conditions of Use

Subscription condition:

- Work further than 2 km away from the car park
- Be a commuter and hold a valid MOBIB card associated with a personal subscription

If the applicant does not qualify for a subscription or if the car park is full, the application will be refused.

If the car park is full, the application will be placed on a waiting list.

If any information is missing, the applicant's file will be considered incomplete and the application will be put on hold. The applicant will have a period of five calendar days from the sending of the email notifying them of the incomplete nature of the file to provide the missing data or documents. After this period, if the data is not provided, the application will automatically be cancelled and the place assigned to the next client on the waiting list. Any change in the data relating to the use of a subscription (change of address, change of employer, replacement vehicle) must be reported immediately to the Agency by email.

All communications are exclusively by email.

By using our services, the subscriber unreservedly accepts these terms and conditions of use and agrees to respect the car park's internal regulations shown on-site.

The Parking Agency reserves the right to refuse a subscription application if the applicant provides inaccurate or incomplete information. In addition, the Agency may immediately cancel a valid subscription if false information is subsequently found. The subscriber will not be entitled to any refund.

Parking Agency personnel will process the personal data provided in compliance with the conditions of the Privacy Act.

Prices and validity

The service is free. Once parking.brussels has received these documents, confirmation of registration is sent by email.

The P+R subscription gives access to the "P+R" area in the UZ Brussel P1 car park, but does not give an entitlement to a reserved space. If the car park is full, a sign at the entrance will display "complet", otherwise it will display "libre". Spaces reserved for P+R subscribers are grouped at the back of the car park over 3 rows of spaces and are clearly identified as such. The P+R subscription does not give free access to the rest of the car park.

The subscription remains valid for one year.

If the user does not use the car park at least once a quarter, parking.brussels may consider that the subscriber does not wish to continue with their subscription and they will no longer have access to the car park.

The subscriber is notified by email when their subscription expires and will be invited to renew it.
